Our personal information handling policy and procedures have been developed in line with the requirements of the 1995 European Union Data Protection Directive (Directive 95/46/EC) and the General Data Protection Regulation (in force from 25 May 2018) and applicable national law.

1. What information do we collect?

We collect and process personal data about you when you initially apply for employment with Cable Services Limited and over the time of your employment. The personal data we process includes:

- Accident and sickness records;
- Your right to work documentation;
- Appraisal and employment performance information;
- Email and internet history from Cable Services Limited systems:
- Images captured from CCTV at Cable Services Limited;
- 2. How do we use this information and what is the legal basis for this use?

We process the personal data listed above for the following purposes:

- As required to establish and fulfil an employment contract with you. This may include verifying your identity, paying wages, communicating with you, providing a pension, and abiding by employment or health and safety law.
- To comply with applicable law and regulation;
- In accordance with our legitimate interests in protecting Cable Services Limited's legitimate business interests and legal rights, including but not limited to, use in connection with legal claims, compliance, regulatory and investigative purposes

- (including disclosure of such information in connection with legal process or litigation);
- With your express consent to respond to any comments or complaints we may receive from you, and/orin accordance with our legitimate interests including to investigate any complaints received from you or from others.
- 3. With whom and where will we share your personal data?

Cable Services Limited will only share information with groups through legal compliance (e.g. health and safety reporting) or with organisations employed by cable Services Limited to provide a service (e.g. pension provider)

1. What information do we collect?

We collect and process personal data when you interact with us and our products and when you purchase or supply goods and services from us. The personal data we process includes:

- Your payment and delivery details, including billing and delivery addresses and credit card details, whereyou make purchases from us.
- Information related to the browser or device you use to access our website;

- Any other information you provide
- 2. How do we use this information and what is the legal basis for this use?
